Introduction to A&A WG

The Advocacy and Accountability Working Group (A&A WG) contributes to the health and well-being of all individuals by ensuring they have access to RH commodities they want when they need them. The group links global and country level technical advocacy, in the areas of policy, finance and programs, to create an environment favorable to scaling up equitable access to a wide range of affordable and high quality RH commodities.

A&A WG Objectives

- The AAWG will deliver technical advocacy at the global, regional and national level to advocate for enabling policy environment, strengthen financial commitments and ensure efficient and effective program implementation, to enhance equity, availability, quality and choice to a wide range of affordable and high quality RH commodities.
- The AAWG will monitor and hold stakeholders at global and country level to account for the delivery of commitments made to increase access to a range of high quality RH supplies.
- The AAWG will provide a hub for sharing best practices, intelligence, developing strategy, linking global and southern advocates and linking technical experts with activists to spearhead and sustain advocacy on the RH commodity agenda.
