





Uganda Health Minister responds to HEPS stockout advocacy

The Ugandan government gets it—that if stockouts of contraceptive commodities were eradicated, four million unplanned pregnancies, half a million unsafe abortions, and 6,000 maternal deaths could be averted by 2020. Uganda's State Minister of Health for General Duties, Sarah Opendi, announced this month that the government had allocated \$2M for the procurement of contraceptives. "No country has ever attained economic development without tackling its fertility rate," Ms. Opendi said. She was responding to the findings of a project implemented by HEPS, with financial support from the Coalition. The project engaged community members, health providers, and local government officials in applying a social accountability tool to reduce contraceptive stockouts. HEPS used the results of that work to address the Ministry of Health, National Medical Store and other national-level partners in order to generate the political will needed to resolve them. RHSC supports UNFPA to digitize country-level data collection

UNFPA and the IT solutions firm, Systmapp, have embarked on a joint initiative to digitize the collection, storage and analysis of Country Questionnaires and Health Facility Surveys conducted annually by UNFPA Supplies in the 46 countries where it operates. The effort aims to enhance data collection and transfer, improve data analysis and reporting, and make possible more informed decisions by UNFPA staff. The new IT solution will also include an external portal, making it possible to access and download country datasets on

RH commodity stocks, and the status of key service-delivery markers.

Two Chinese partners receive positive product ratings from WHO

This month, Beijing's Zizhu Pharmaceutical Co., Ltd. received WHO prequalification of its misoprostol 200µg, the second Zizhu product to receive that coveted status in as many months. This month also saw Coalition member Shanghai Dahua Pharmaceutical Co., Ltd, obtain the highest rating from the WHO Expert Review Panel for its two-rod sub-dermal implant, Sino-implant (II), which the firm intends to market under the global brand name Levoplant. Both awards represent a significant milestone in the global supply of high-quality reproductive health products.

UNFPA screens Coalition video on stockouts

Participants at this month's semi-annual meeting of UNFPA Supply Partners were treated to a repeat performance of the Coalition's video on last mile supply chain struggles, which was first screened in Seattle at the Coalition's general membership meeting. Some 50 participants including donors, the private sector, and civil society, watched the three-minute film calling partners to work together, as "no single agency can do it alone". Ghent University conference showcases Innovation Fund work

Ghent University hosted to a lecture on the results of an Innovation Fund-supported initiative that linked staff motivation and good supply management in 15 primary health care facilities in Mozambique. The research, carried out by the university's International Centre for Reproductive Health, explored how—and to what extent—the motivation of providers can be optimized to reduce the frequency of stockouts. The lecture took place at a meeting of the recently-established Academic Network for Sexual and Reproductive Health and Rights Policy (ANSER), which is an alliance of international universities

designed to be a global resource for SRHR policy research, education and service delivery. A <u>report</u> of the findings and a <u>policy brief</u> based on the findings are online.

Recent webinar on drones now available online

USAID, JSI and ForoLAC recently co-hosted a Spanish-language webinar, describing the experience of companies that use unmanned aerial vehicles – or drones -- to deliver medical supplies in countries as diverse as the Dominican Republic, Rwanda, Papua New Guinea and Madagascar. A recording of the event is <u>available</u> on the Coalition's hub, which now hosts 42 webinars in all.
