# FondsSECONAF helps shine a light on Congo-Brazzaville's supply needs

The Coalition's small grants fund for Francophone Africa, FondsSECONAF, has shed light on the supply needs of a country largely sidelined by donors: Congo-Brazzaville. A small grant to that nation's IPPF member association, <u>ACBEF</u>, has made it possible to identify the bottlenecks hindering the flow of supplies and begin putting in place the means to overcome them. ACBEF found that with no public budget for supply distribution, 40 percent of health facilities and warehouse relied on public transportation, with providers often footing the transport costs themselves.

To address this issue, ACBEF trained key clinical staff in logistics management, and set up a national coalition of NGOs to persuade public officials to prioritize RH supplies distribution, create an appropriate budget line for that purpose, and establish a new national warehouse in the north of the country.

### Scholarships awarded to 10 young supply chain managers

LAPTOP Scholarships were recently awarded to 10 young supply chain managers from Ghana, Guinea, Ethiopia, Kenya, Nigeria, Solomon Islands, Togo, and Uganda. The five women and five men will further their studies in supply chain management in respected institutions ranging from Pamela Steele Associates and Empower School of Health to the Chartered Institute of Procurement and Supply. They each bring with them different passions and experiences—from humanitarian healthcare to health economics and pharmacy. This third round of scholarships is funded by the David and Lucile Packard Foundation, with People that Deliver supporting the candidate selection process.

## Fact sheets to inform on contraceptive security in Latin America

A suite of new **fact sheets** is now available in Spanish, mapping the status of contraceptive security in 12 Latin American countries, and providing key decision makers with an easily accessible tool for comparing national progress in the region. The fact sheets use data collected by **ForoLAC** and the USAID project GHSC-PSM for contraceptive safety indicators created by USAID / DELIVER in 2009, addressing years of absence of data on Latin American countries. Indicators include national shortages and market barriers, the manufacturing base for each method, and political barriers to contraceptive access, making them useful advocacy resources for civil society and governments. Countries covered are: Argentina, Bolivia, Chile, Dominican Republic, Ecuador, El Salvador, Guatemala, Honduras, Mexico, Nicaragua, Paraguay, and Peru. More than a hundred government officials attended a dedicated webinar for governments, and a **general webinar introduction** drew nearly 300 registrants.

# Hormonal IUD now included in USAID catalogue

In April 2021, the levonorgestrel-releasing intrauterine device (IUD) - also known as the **hormonal IUD** - was added to the **USAID Product Catalog**, the specific products being MirenaTM, supplied by **Bayer AG**, and AvibelaTM, supplied by **Impact RH360**. Aimed at facilitating procurement and distribution in low- and middle-income countries (LMICs), this addition will allow USAID's **family planning priority countries** to procure hormonal IUDs. This development is a culmination of many years of research and investment, which included Innovation Fund support to FHI 360 to assess the potential to introduce the hormonal IUD into Kenya. That pioneering work helped create an interest in the broader introduction of the method in LMIC markets and helped establish costing parameters for the product. ## VAN members enjoy tailormade knowledge management options

The VAN – dedicated to data transparency, information sharing, and collaboration -- has launched a new resource to support its members' knowledge needs. The Information Portal (Portal) is a SharePoint site that allows members to access advocacy and training tools, meeting recordings, and other resources that support member interaction. Members can now share and collaborate on content without having to request separate viewing permissions, as was the case with the Portal's predecessor. Each member now also gets access to a suite of folders individually tailored to their particular role in the VAN. The upgraded Portal is part of the VAN's ongoing evolution to meet user needs and make for better collaboration between its members.
