## Mifepristone included in Ecuador's Essential Medicines List

Ecuador's Ministry of Health has successfully included mifepristone in its National Essential Medicines List. The long process leading up to this moment was supported by RHSC/[ForoLAC](#) and partners from [CLACAI](#) and [IPAS](#), who provided up-to-date scientific evidence on the use and effectiveness of mifepristone as a safe abortion medication when used in combination with misoprostol. Ecuador's accomplishment has pushed forward the availability of this key obstetric medicine in the region, just weeks after Argentina's national laboratories [became the first LAC producer](#) of mifepristone.

### **Ambitious targets drive Ouagadougou Partnership meeting**

In December, RHSC representatives joined West African stakeholders in Abidjan at the Ouagadougou Partnership (OP) annual members meeting bringing together countries committed to reaching 13 million modern contraceptive method users by 2030. Participants discussed leveraging the VAN to further country contraceptive security goals, planning with WAHO to expand the reach of the West Africa Regional Committee for Reproductive Health Supply Chain Data Visibility in partnership with OP and FP2030, and providing direct supply chain support to existing VAN government members from Benin, Burkina Faso, Togo, Cote d'Ivoire, and Senegal.

### **Martyn Smith on the next ‘pivotal decade’**

In his closing message for 2023, RHSC Director Martyn Smith anticipates a year in which the community’s common purpose and resolve will “continue to be tested by a myriad challenges in an era of VUCA (volatility, uncertainty, complexity, and ambiguity)”. But through its new strategy, the RHSC will provide a platform for our members to be bold and demonstrate sector-shaping leadership as we meet these challenges, he says. ### Webinar offers insights into FP Market Report

Last month, we announced the launch of the [2023 Family Planning Market Report](#) by the Clinton Health Access Initiative (CHAI) and the RHSC. The report found that over 2018-22, the public-sector contraceptive market grew from US\$247 to US\$257M in low- and lower-middle income countries, with long-acting methods comprising the majority of couple-years of protection over this period. During the webinar, a panel of experts — Marie Chantale Lepine and Zainab Saidu from CHAI, Ntindah Luembe (RHSC), and Jason Bremner (FP2030) — offered perspectives on the report.
